Consignment Contract

Thank you for choosing Little Tykes Trading Post for your consignment needs. We are pleased to have you as a consignor and look forward to building a relationship with you. We would like to outline the consignment rules/guidelines to keep communication clear between Little Tykes Trading Post and you. By following these few guidelines, this will assure Little Tykes Trading Post in maintaining very high standards and offer top quality items and clothing to our customers.

We will sell the items for you on a consignment basis. Once the item sells, you receive 40% of what the item sold for. The consignment period is 60 days and items automatically become property of Little Tykes after the 60 day consignment period. The majority of items that do not sell are donated to one of our many charities and you may obtain a tax donation form from us if you request one.

1. We accept clothing sizes 0-10, maternity clothes, baby toys, equipment, furniture, books/games, videos, and DVDs that meet Little Tykes Trading Post standards. Car seats and bike helmets are not accepted items.
2. All clothing must be freshly laundered, ironed, in good condition, and presented on plastic hangers before bringing into the store for consignment. Clothing needs to be free of stains, rips and tears, etc. If needed, hangers can be provided by Little Tykes Trading Post at no charge. **CLOTHING MUST BE BROUGHT IN ON PLASTIC HANGERS.** Please make sure that all zippers and snaps work, and all buttons are present and intact on each item of clothing if applicable. The better your items present, the better they will sell. Small preparation fees may be added to items that require a staff time to prepare the items for selling.
3. Toys and equipment must be in good working order and also be clean and free from stains, tears, missing pieces, etc. Toys that require batteries need to have working batteries present or a battery fee (\$1-\$4) will be charged to the consignor. Keep in mind the importance of the presentation of your items and if the toy is working because of new batteries, it will sell faster and for more money.

4. For any equipment such as strollers, swings, cribs, etc., that require cleaning in order to present to our customers, the consignor may be charged a cleaning fee ranging from .50-\$5.00 depending on the size of the item and the extent of the cleaning.
5. You may bring in as many items for consignment as you would like however, please keep in mind that bringing in a significant amount at one time (over 50 items) may be a fairly slow process to get checked in. We realize that your time is valuable and want to make the best use of it.
6. Items are reviewed with you upon the initial intake process. Some items will be declined and returned to you or you may request for us to donate the items for you. If items are donated after the initial intake process (due to missing parts, stains etc, not seen initially), there is a .15 handling fee per item. This fee is deducted from your consignor account. This helps to cover our costs during this labor intensive process and provides a huge service to our many charities. This is also put into place as an incentive for consignors to carefully review all items prior to bringing them in for consignment.
7. Prices are determined by Little Tykes Trading Post and can be changed per our discretion.
8. Little Tykes Trading Post will not accept or sell items that have been recalled according to the Consumer Product Safety Commission. You may want to refer to the government website for additional information at www.cpsc.gov.
9. Consignment percentages will be paid to you at 40% once the items are sold. Items will be marked down after a designated period of time (usually after 60 days--to be determined by Little Tykes) to keep merchandise moving and to avoid items being on the racks for an extended period of time. This allows room for new merchandise to keep coming into the store, and allows for you to get paid on a timely basis. Expired items may be used for our routine bag sales or they may be donated to one of our charities.
10. Consignment payments are available once the item has been sold for 10 days. This allows time for any items that may be returned. It is your responsibility to pick up consignment payments. If you request that a check be mailed to you, this can be done however a \$1 processing fee is taken out of your account prior to writing the check. After six months of available money in your account and at least two attempts from Little Tykes to contact you, your uncollected money becomes property of Little Tykes Trading Post.
12. There are small item/buyer fees for each item that is put on consignment. This is an inexpensive processing fee (for screening, hanging, entering and, tagging etc.) to help to keep your costs down and to prevent Little Tykes from having to utilize annual consigner fees.
